### **AGENDA ITEM NO. 3**

**Subject: Acquiring of land for new Dumping Ground - regarding.**

The proposal for identification and procurement of a site for new Dumping Ground was placed before the General House of Corporation in its 154<sup>th</sup> Meeting held on 30.6.2010 vide Agenda Item No. 25. The House desired that land be reassessed by the Technical Expert for new Dumping Ground for next 20-25 years.

Since the consultancy was provided by the Consultant in the past for capping, covering & closing with sanitary landfill under CPCB Project, the Consultant M/s Eco Design India Pvt. Ltd., Pune was requested to kindly assess the land required for U.T. Chandigarh through E-Mail. The Consultant has given the reply which is as under:-

- Waste going to landfill – 100 TPD in the year 2010
- Waste going for composting plant – 50 TPD from Sabji Mandi and 50 TPD not being taken by JP Associates for processing in 2010.
- Duration – 25 years
- Increase in waste at 2% per year for 25 years for both Landfill and composting.

On the basis of the same, the consultant has assessed the land as approximately 35 hectares. 1 hectare = 2.4711 acre i.e approximately 85-86 acres required for next 20-25 years. The requirement of land has been estimated on the basis of compost plant and landfill for 25 years. A green plantation and road of 6 m each all around the site has also been considered in the above area.

In view of 100 acres of land identified by the Land Acquisition Officer, across Patiala Ki Rao which is more than 0.5 Km. away from habitation clusters as per the site selection criteria, if approved, the request will be made with the Chandigarh Administration to identify 85 acres keeping in view the requirement for next 20-25 years after the approval of General House.

The matter was placed before the Sanitation Committee for its consideration and approval please. The Committee after deliberations resolved and approved to place the Agenda before the General House for acquiring 85 acres of land for new Dumping Ground keeping in view the requirement for next 20-25 years. The proposal has also been examined by the Chief

Engineer Municipal Corporation Chandigarh and the same is recommended. In view of above, the matter was again placed before the 156<sup>th</sup> meeting of General House of Corporation on 25.8.2010 for its consideration and approval.

The House desired to seek the report from the Chandigarh Pollution Control Committee regarding the environmental issues.

It is pertinent to mention that the matter was taken with the Chandigarh Pollution Control Committee in the past and the Member Secretary has intimated that environment clearance is required as per Environment Impact Assessment Notification dated 14.9.2009 (Available on [envfor.nic.in/legis/eia/so1533.pdf](http://envfor.nic.in/legis/eia/so1533.pdf)), from Ministry of Environment & Forest. Further it was also informed that common consent under Water Act, Air Act and authorization under Hazardous Waste (Management & Handling Rules) along with authorization under Municipal Solid Waste Rules from Chandigarh Administration is required.

In view of the above, land is required to be identified and approved before the environment clearance is sought from the Ministry after preparing Environment Impact Assessment Report after engaging the consultant before the Detailed Project Report is submitted with the Ministry of Environment & Forest, New Delhi.

In view of above, the matter is again placed before the General House of Corporation for its consideration and approval please.

The area councilor vide his letter dated 26.07.2010 has requested to provide paver blocks for improvement of walkway in Sector 28-D near houses & sector dividing road Sector 27-C and Sector 28-D, Chandigarh to facilitate the general public.. Accordingly a rough cost estimate amounting to Rs.43.36 lacs has been prepared for arranging administrative approval and allotment of funds. The estimate includes the following scope of works:-

The area councilor of Ward No.18 has requested that 60mm thick interlocking paver blocks in front of Radha Swami Satsang Bhawan, Sector 27-D, Chandigarh, in front of H.NO.1355-1370, Sector 28-B and in front of H.No.1033/1-1044/1, H.No.1001-1016, Sector 30-B, Chandigarh may be got fixed to facilitate the general public. It will facilitate the pedestrian for smooth walk and also avoid the accident. Accordingly a rough cost estimate amounting to Rs.38.85 lacs has been prepared for arranging administrative approval and allotment of funds. The estimate includes the following scope of works:-

## **AGENDA ITEM NO. 7**

**SUBJECT: ESTIMATE FOR THE WORK OF “RAISING OF BOUNDARY WALL AND STRENGTHENING OF BARBED WIRE FENCING, CONSTRUCTION OF PATH WAY AROUND THE BOUNDARY WALL FOR SECURITY ARRANGEMENT AT WATER WORKS, SECTOR-39, CHANDIGARH.”**

A meeting to review the security arrangement of water works, Sector-39 was held during 2009 (Minutes attached) wherein it was suggested to implement various points discussed in the meeting. As per minutes of meeting, it was decided to increase the height of existing boundary wall by two feet and to provide angle iron posts & fencing, construction of cycle track-cum-service lane i.e. concrete path, construction of watch towers, security lights, provisions of metal detectors etc. Thus for security purposes the height of existing boundary wall of water works sec. 39, Chandigarh is proposed to be raised and 'Y' shape barbed wire fencing is to be provided. Further for patrolling and proper inspection, 4'-6" wide cement concrete path is also proposed to be constructed along boundary wall of water works. The other provision i.e. arrangements for high power lights, CCTV Cameras and metal detector etc. shall be covered under separate estimate. Thus the estimate for Civil works duly checked for **Rs. 83.40 Lacs** has been allowed by the competent authority to be placed before the General House of Corporation for consideration and approval.

Accordingly the agenda is hereby placed before the General House of Municipal Corporation. The expenditure will be charged to head: 4215 – Water Supply and Sanitation (Plan) – Renovation of civil works and more funds will be demanded in RBE. However the detail of Budget allocation is as under:

**SUBJECT: ESTIMATE FOR THE RE-CONSTRUCTION OF BOUNDARY WALL AROUND WATER SUPPLY HOUSES IN PLACE OF EXISTING DAMAGED/ BROKEN BOUNDARY WALL AT WATER WORKS SECTOR-39, CHANDIGARH.**

The existing boundary wall around Water Supply Houses at water works, Sector-39, Chandigarh is of low height and also broken at some places. The residents of water supply colony have demanded for increased height of the boundary wall due to security reasons. Now as the existing boundary wall is of low height and for increased height it has to be made structurally safe. For this old brick wall will be dismantled and RCC columns & beams will be used for construction of new brick boundary wall and Y-shape angle iron by with G.I. barbed wire fencing will be provided. It is assumed that about 60% of the old bricks shall be re-used and remaining 40% new bricks shall have to be provided. The suitable credit for old bricks has been considered in the estimate. Thus the estimate duly checked for **Rs. 39.17 lacs** has been allowed by the competent authority to be placed before the House of Corporation for consideration and approval.

## **AGENDA ITEM NO. 9**

**Subject: Estimate for the Repair and renovation of Pump chambers and construction of boundary walls of various tubewells i.e. RN-20, RN-21, RN-22, RN-26, RN-52, RN-61, RN-77, RN-82, RN-83 and RN-91 located in Forest area under MCPH Divn. No. 1, Chandigarh.**

The civil structures i.e. pump chambers and chowkidar residence of various tubewells under the jurisdiction of MCPH Division No. 1, Chandigarh are very old and no special repair/renovation has been carried out since the inception of Municipal Corporation. These tubewells i.e. RN-20, RN-21, RN-22, RN-26, RN-52, RN-61, RN-77, RN-82, RN-83 and RN-91 are located in forest area and civil structures are without boundary walls and in deteriorated condition which need immediate renovation alongwith construction of boundary walls etc. Further these tubewells are operated remotely through SCADA system but for watch and ward of these tubewells Mali-cum-Chowkidars have been deployed. Thus apart from the repair & renovation of pump chambers and construction of boundary walls, it is also essential to provide the facility of toilet to ease-out by the staff at these tubewells. As the tubewells are located in forest area and there is no sewerage line nearby, therefore, Septic tanks are also required to be constructed. Further to prevent unauthorized entry and for safety of pumping machinery and other installations of tubewells, 6 feet high brick boundary walls are required to be constructed. However, the tubewells which are located on road side, the boundary wall of low height alongwith MS welded Mesh has been proposed. The other provision such as approach path, paver blocks etc. are also proposed to be constructed. Thus the estimate duly checked for **Rs. 41.24 lacs** has been allowed by the competent authority to be placed before the General House of Corporation for consideration and approval.

## **AGENDA ITEM NO. 10**

**Subject: Rough Cost Estimate for Widening of V-5 road and P/F 60mm thick interlocking paver blocks in Sector 5, Chandigarh.**

**(Amount: Rs. 41.29 Lacs)**

The V-5 road of Sector 5 was last carpeted in May/2007. The present width of road is 24'-0", which is insufficient to cater the high density of traffic on this road. Moreover, Area Councillor has also desired to widen this road. On inspection of this road, it was revealed that the widening is only feasible on one side, as such, the camber correction will have to be carried out for the smooth riding of the road surface and over which the overlay / renewal coat of the carpeting work will become essential. It will be pertinent to mention that the items incorporated in this estimate have not been taken in any other approved estimates.

Accordingly, this rough cost estimate amounting to Rs. 41.29 lacs has been prepared. The scope of work taken in the estimate is as under:-

**Subject: RCE for P/L 40mm thick bituminous concrete on V-5 road from Haryana new Secretariat to slow carriage way in Sector – 17, Chandigarh.**

**(Rs. 71.49 lac)**

The V-5 road in Sector – 17 from Haryana New Secretariat to Slow carriage way inspected by the Executive Engineer Roads Division 1 and the Sub Divisional Engineer, Roads S/Divn. 1 M.C. and observed that lot of cracks and pot holes have developed on the road surface, causing inconvenient to the public. These roads were last carpeted in the year 12/2003 and due to recarpetting. Accordingly the rough cost estimate amounting Rs. 71.49 lac with the following scope of work has been framed.

1. Dismantling of existing kerbs.
2. Dismantling of existing channels.
3. P/F 40mm thick factory made cement concrete interlocking paver blocks.
4. Providing and applying tack coat grade 80/100 @ 3 Kg/10 sqm.
5. Providing and fixing PCC of size 1'x1' having 4' thickness.
6. Fixing of new/old PCC channels.
7. Providing and applying 2.5mm thick road marking strips.
8. Provision for providing and fixing road signboards, delineators etc.

**Subject:** Detailed Project Report (DPR) for replacement & augmentation of trunk brick sewers by RCC NP-3 Pipes with Sulphate Resistant in U.T. Chandigarh under JNNURM Scheme (*Amended as per CPHEEO observations*)

**Project Cost: Rs.123.04 Crores.**

A detailed project report for “Replacement and augmentation of trunk brick sewers by RCC NP-3 pipes with Sulphate Resistant Cement alongwith with P.E.Lining in U.T.,Chandigarh (Phase –I) under JNNURM was prepared amounting to `114.37 Crores .The project was approved by the House of Corporation in its 153<sup>rd</sup> meeting held on 29.4.2010 .

This project was submitted to Ministry of Urban Development, New Delhi CPHEEO under JNNURM scheme with due approval of SLNA for consideration and approval. The Ministry of Urban Development has raised some observations vide letter no.12045/31/1 NURM/2010/CPHEEO dated 19.8.2010. As per requirement the sewer for the designed for 30 years i.e upto 2041,the DPR amended with replacement of all sewers which were laid in Phase 1 & 2 with RCC NP-3 pipes Sulphate resistant without P.E. lining. The other observations have also been taken care of. The detailed reply to the observations is attached in the DPR .

The amended DPR amounting to `123.00 Crores is submitted for approval of the House of Corporation. After its approval by the House, the same will be submitted to Chandigarh Administration SLNA for further submission to Ministry of Urban Development, Govt. of India for sanctioning the same under JNNURM. The funding pattern under JNNURM for Chandigarh being capital city is as under as per guidelines issued by Govt. of India. The MoA was signed between the Joint Secretary, Ministry of Urban Development(Govt. of India) ,Finance Secretary, U.T.,Chandigarh & Commissioner, Municipal Corporation, Chandigarh on 27.10.2006 .Cost sharing pattern is as under:-

1. MoUD, Govt. of India	80% of sanctioned amount of DPR
2.Chandigarh Administration	10% of sanctioned amount of DPR
3.Municipal Corporation, Chandigarh	10% of sanctioned amount of DPR
