The office of Chief Architect, Department of Urban Planning, U.T., Chandigarh vide his office Memo No.14784 dated 08.12.2010 supplied Drawing No.5&6 of Job No.2207 showing the layout plan and plan of Sports Complex at Village Dadu Majra for checking the site feasibility.

Subject: - Providing and laying 40mm thick Asphaltic Concrete on V-4 Roads in Sector 32, Chandigarh.

(Approx. Amount: - Rs.48.89 lacs)

The road V-4 Road of Sector 32 was lastly carpeted in the year 11/2006. As per policy of Municipal Corporation, the recarpeting is to be done after 5 years, which is due for recarpeting during this year. The site was inspected by the E.E.R-II and the SDE concerned and it has been found that the road is in poor condition and developed map cracks on road surface and required immediate recarpeting. Accordingly a rough cost estimate amounting to Rs.48.89 lacs has been prepared for arranging administrative approval and allotment of funds. The estimate includes the following scope of works.

1. Providing and fixing PCC kerbs of size 2'-9" having 4" thickness.
2. Providing and fixing PCC channels of size 2'x1' having 3" thickness.
3. Providing and laying tack coat
4. Providing and laying 40mm thick A.C.

The road V-5 Roads of Sector 29 A&B were lastly carpeted in the year 06/2006. As per policy of Municipal Corporation, the recarpeting is to be done after 5 years, which is due for recarpeting during this year. The condition of this road is poor. The site was inspected by the E.E.R-II and the SDE concerned and it has been found that the site is feasible for widening and carpeting. Accordingly a rough cost estimate amounting to Rs.114.25 lacs has been prepared for arranging administrative approval and allotment of funds. The estimate includes the following scope of works. Moreover, the PCC tiles laid during 2005 will be dismantled and 15 to 20% of retrieved material will be taken on R.M.R.

Terms and conditions

1. Selection will be done on the basis of experience and merit by the standing committee constituted by the Commissioner, Municipal Corporation, Chandigarh.

2. The Municipal Corporation shall be empowered to issue directions to the Management of the NGO/ Registered Body/Individual Body if some defects are noticed in the management of the Gaushala and the same shall be binding upon them.
3. The NGO/Registered Body/Individual Body will make arrangement for periodical medical checkup of the animals by a qualified Veterinary Doctor.
4. The NGO/ Registered Body/Individual Body will maintain proper record in respect of the animals kept in the Gaushala and appropriate arrangements will be made by the them to provide facilities to the impounded animals.
5. The day to day maintenance of the premises of the Gaushala shall be the sole responsibility of the NGO/ Registered Body/Individual Body including sanitation, hygiene and cleanliness.
6. The cow dung and urine shall be the property of the NGO/ Registered Body/Individual Body and can be utilized for generating income. The NGO/ Registered Body/Individual Body will run the premises and other facilities to the satisfaction of Municipal Corporation.
7. The Municipal Corporation shall conduct inspection of the Gaushala from time to time to ensure its proper upkeep and care of the stray animals by the NGO/ Registered Body/Individual Body.
8. That the water and electricity charges shall be paid by the NGO/Registered Body/Individual Body as per the bills.
9. No structure temporary or permanent shall be raised by the NGO/ Registered Body/Individual Body on the premises without prior approval of the Municipal Corporation. The existing structure of Gaushala will continue to remain under the sole ownership of the Municipal Corporation.
10. Fodder & Medicines shall be provided by the NGO/Registered Body/Individual Body at their own expenses.
11. That the NGO/Registered Body/Individual Body shall not sublet the said premises to anybody, as a whole or in parts directly or indirectly.
12. That the Commissioner or his authorized representative can enter at any time upon the premises to assess the state and condition thereof.
13. That the NGO/Registered Body/Individual will get the repair of the said property at their own basis.
14. That the NGO/Registered Body/Individual Body shall use the premises for cowshed purposes only and will use the residential room for the purpose of security to be deployed therein.
15. That the NGO/Registered Body/Individual Body will ensure that the Cow/Dung is removed from the premises within 48 hours in Gaushala for which he will deploy his own machinery.

16. That on expiry of the lease period/termination of this lease, whichever is earlier, the NGO/Registered Body/Individual shall hand over vacant physical possession of the said premises within 48 hours to the said Municipal Corporation in as good condition as the NGO/Registered Body/Individual Body has received.
17. That the NGO/Registered Body/Individual Body shall not make any additions or alterations in the said premises without the prior written consent of the Municipal Corporation.
18. That the NGO/Registered Body/Individual Body shall not carry on or cause to be carried or any obnoxious trade or activity in the said premises and NGO/Registered Body/Individual Body shall not misuse the said premises in any manner.
19. That the NGO/Registered Body/Individual Body shall strictly abide by the rules and regulations imposed by the Local Estate Office, U.T. Chandigarh and Municipal Corporation Chandigarh etc. and in case any tax or charge is levied by the above said local authorities the same will be paid by him.
20. That the lease will be for 5 years from allotment/signing of lease deed. The lease money will be as fixed by the Municipal Corporation, Chandigarh. The same shall stand terminated on the completion of the lease period unless it is renewed by mutual agreement before this date. No separate notice will be required for this purpose.
21. The Municipal Corporation has the right to amend alter and introduce fresh guidelines as and when required.
22. The Commissioner, Municipal Corporation, Chandigarh reserves the right to cancel any or all the EOI's without assigning any reason thereof.
23. The possession of the Gaushala will be given to the eligible NGO/Registered Body/Individual Body on 'As is where is basis'.
24. Only one Gaushala will be handed over to one NGO/Registered Body/Individual Body for its maintenance and operation.

- Subject: i) Amended Draft Recruitment Rules of Group-A, B, C & D of Municipal Corporation, Chandigarh.**
- ii) Filling of vacant posts of SDEs by promotion as one time measure.**

As per the decision of the 157th meeting held on 29.09.2010, the draft recruitment rules were placed before the House for consideration. The House passed the following resolution:-

“The House considered and unanimously resolved that the Mayor shall constitute a Committee of 5 members, which will review the Recruitment Rules and hear the officials and officers and submit report to the House. The agenda was deferred.”

The matter was accordingly referred to the committee.

The objections/suggestions of the employees of MCC as well as Associations/Unions of the employees were invited on the Draft Recruitment Rules as per directions of the above said committee. After taking into consideration the objections/suggestions received, the committee amended the Recruitment Rules of Group A, B, C & D of all the wings of Municipal Corporation, Chandigarh.

The amended Draft Recruitment Rules duly signed by the Members, are placed before the House for consideration.

- ii) Filling of vacant posts of SDEs as one time measure.**

On the formation of MCC Junior Engineer's/Assistant Engineer's were transferred from the Engineering Wing of Chandigarh Administration in the Municipal Corporation Chandigarh in year 1996. They are working on the same post for the last about 16 years. After detailed discussion, the committee recommends for the promotions of Junior Engineers/Assistant Engineers as SDEs as one time measure to clear the stagnation amongst the employees as they are having sufficient experience and required qualification for promotion. Subject: Comprehensive Maintenance Contract for 3 No. Large Road Sweeping Machines Model Dulevo-5000 from 8.4.2011 onwards.

It is submitted that Municipal Corporation Chandigarh had procured 3 No. of Large Road Sweeping Machines from M/s Dulevo International Spa, Italy in the year 2008. The said machines remained under guarantee/warranty till 31st August, 2009. An agenda was placed before the General House of Municipal Corporation Chandigarh with the rates of Comprehensive Maintenance Contract and Annual Comprehensive Maintenance Contract as per the terms and conditions of the company. General House of Municipal Corporation Chandigarh in its 152nd meeting held on 26.3.2010 taken following decision:-

“The House considered and resolved that the proposal to give Annual Comprehensive Maintenance Contract for 3 Road Sweeping Machines Model Dulevo-5000 Evolution to M/s Dulevo India Private Limited, B -116, Sector 5 Noida @ Euro 18000 considering 1 Euro INR 68.5 i.e. INR ` 12,33,000/- per machine at a total cost of ` 36,99,000/- + Service Tax, be and is hereby approved.”

As per the approval of General House, Annual Comprehensive Maintenance Contract was given to M/s Dulevo India Private Limited, B -116, Sector 5 Noida for a period of one year which will expire on 8.4.2011. The services of the Company remained satisfactory during the said contract and the machines remained functional without any breakdown.

It is proposed that Annual Comprehensive Maintenance Contract be renewed for another one year on the same terms and conditions to maintain the continuity of proper services. However, the value of 18000 Euro will be calculated from the day of renewal of contract i.e. the value of EURO as on date is ` 60.63 INR i.e. INR Rs.1091340/- per machine and at the total cost of ` 3274020/- + service tax for 3 No. Large Road Sweeping Machines.

In view of above, the Comprehensive Maintenance Contract be renewed with M/s Dulevo India Private Limited, B -116, Sector 5 Noida.
