

# MUNICIPAL CORPORATION CHANDIGARH

## PUBLIC NOTICE FOR CABLE OPERATORS

This public notice is issued in public interest and for strict compliance on part of all the cable operators doing their business in the area of U.T., Chandigarh:-

1. All cable operators are required to intimate the Municipal Corporation, Chandigarh through an affidavit regarding their area of operation i.e. their official address and contact phone numbers. **(Before 15.8.2011)**.
2. They shall submit a sketch plan street wise for each sector of their area of operation. **(Before 15.8.2011)**.
3. *All the cable operators should deposit the ground rent quarterly advance by 10<sup>th</sup> of the month at the start of each quarter, failing which cable operators shall be liable to interest @ 15% per annum from the first day of the month in which the payment falls due up to the date of actual payment.*
4. *The cable operators, who are found defaulter on three occasions, would not be permitted to run the cable business in the city of Chandigarh.*
5. *The poles and cable of the defaulters, who do not clear the dues in spite of notices, shall be removed from the area by the Municipal Corporation, Chandigarh.*
6. They should regularly deposit a fee of Rs. 1000/- P.M. for a Sector and Rs. 500/- P.M. for a part (less than half) of a sector as ground rent.
7. They should issue proper printed receipts against the charges collected from the consumers. The receipt should clearly depict their name, address, contact nos. etc.
8. They should mark and paint their poles, amplifier junction boxes and attach their printed placards for identification of their lines.
9. They should also submit the valid licence obtained from the competent authority for running their business as cable operator. **(Before 15.8.2011)**.
10. They must inform in writing to the Municipal Corporation as and when

they close their operations or change the name of their agency or in case they handover their business to some other agency.

11. All the residents and citizens who are customers and consumers of cable services are also advised not to make any payment to a service provider who does not issue any printed receipt i/c all the details as mentioned in point no. 7 above.
