

**Detailed Information of Short Term Tender for the supply of
Dry Fodder (Turi)**

The tenders brought personally should be deposited in the tender box placed in Room No.8, Ground Floor, 30 Bays Building, Sector 17, Chandigarh on dated 10.3.2011 up to 2.30 P.M. and will be opened on the same day at 3.00 P.M. in the office room of Medical Officer of Health, Municipal Corporation 30 Bays Building, Sector 17, Chandigarh in the presence of tenderers who may wish to be present.

Terms and Conditions:-

1. The tenderers shall initial all cuttings in the Tender. In case of non-compliance with the conditions, the tender will stand rejected.
2. Due to seasonal variation the rate should be quoted in two parts i.e.
**From March to August
and
From Sept. to February**
3. The rates quoted should be F.O.R. in the Cattle Pound situated in Industrial Area, Phase I, Chandigarh & Gaushala situated at Maloya & Sec.45.
4. The tender shall consist of two parts i.e. Envelope I should contain earnest money as mentioned above in the shape of C.D.R. duly pledged in favour of Medical Officer of Health, Municipal Corporation, Chandigarh issued by Scheduled Bank and Envelope II should contain the price bid. The price bid of such tenderer(s) shall be opened whose E.M.D. is found in order.
5. The tender received without earnest money will be rejected.
6. Conditional Tender will not be accepted.
7. No advance payment will be made to any supplier.
8. Tenderer must sign the tender rates.
9. The supply order will be placed on need basis as per requirement.

10. The quantity mentioned above can be increased/decreased.
11. The earnest money of the successful bidder will be retained as security and the same shall be refunded after successful completion of Work.
12. In case the contractor fails to supply the material in time, Municipal Corporation shall be at liberty to procure the supply from any other source at the risk and cost of the contractor.
13. In case Condition No.11 or 12 of the tender is not complied with by the tenderer, the Corporation shall be at liberty to take steps to allot the work to L-2 firm and the security money shall stand forfeited and the firm can be blacklisted.
14. The firm applying should not have been blacklisted by any Govt./Chandigarh Administration/Board etc.
15. Sub- standard material will be straightway rejected.
16. The material shall be got weighed from the Govt. approved Weigh-bridges only.
17. The Commissioner, Municipal Corporation, Chandigarh reserves all rights to cancel or accept /reject any or all tenders without assigning any reason.
